Choir Scholarship Application

This form is based on the application for tuition assistance of St. Brigid School. If you are already applying to the school for financial assistance, you do not need to fill in these same details on this form, nor do you need to submit any tax documents.

Choir scholarships are available on the basis of merit and/or financial need. If you would like to apply for a scholarship on the basis of merit alone, you may skip the sections asking for salaries and assets. Please note that scholarships based on merit alone will be somewhat lower in amounts and priority than those based on merit and financial need.

To qualify for consideration for a choir scholarship, the following requirements must be met:

1. The parents must make a formal application each year.
2. The student's participation and attendance record must be within acceptable limits. Since St. Mary's Cathedral is funding this program through private donations, the student's attendance and punctuality at choir events at the cathedral will be given priority consideration.
3. Parents of choir scholarship recipients must agree that their student(s) will be enrolled in the choir for the entire following academic year.

In addition, recipients of choir scholarships must be available to sing in the chamber choir if asked to do so.

These requirements must be met before this request can be given consideration. A new application must be completed and submitted each time a renewal of aid is requested.
